# Georgia State Agency Policies and Resources for Transition Aged Youth and Young Adults (TAYYA)

The transition from adolescence to adulthood may bring about a number of challenges and concerns for youth and families, particularly those in need of behavioral health or other supportive services. TAYYA (ages 14-26 years) often face challenges and concerns centering on such topics as post-secondary education, employment, health and healthcare, finances, and housing. Additionally, services and supports often become less available and more disjointed as a youth ages into a legally defined adult.

The resource list below was compiled by the Georgia Interagency Directors Team (IDT), and seeks to take an initial step in providing Georgia TAYYA and families with information on pertinent policies, services, and other informative resources. IDT is a multi-agency, public-private collaborative of child serving agencies, advocates, and other partner organizations, dedicated to improving the behavioral health outcomes of Georgia's children and promoting the System of Care in Georgia.
