		Leslie Lipson When students are included in their classroom and community, they are more likely to have increased quality of academic instruction, stronger friendships and access to the good things in school: clubs, sports teams, field trips, parties and academic content knowledge. If we can assist people, specifically students, to move into valued roles, we increase the likelihood that they will have access to these good things. This is Social Role Valorization, and this philosophy is deeply embedded in the very idea of a
		quality education for all students. Using powerful stories of students who have experienced valued social roles in their community/school and the impact to their life as a result of experiencing belonging and membership, Parent Centers can help families focus on the vision needed to guide our actions to effectively support students to be active, engaged, and to make contributions during the day.

Patterson C	Developing Compassion, Strategy and Resiliency when Assisting Families to Support New Behaviors Leslie Lipson and Daniel Parker Part 1: This session is meant to inform staff about methods to support families seeking a plan to access meaningful supports when their child exhibits behavior problems in school including difficulties with anxiety, self-regulation, or behaviors that may be triggered based on a traumatic event. We will provide you with ideas to help the family understand their rights, the processes to address behavior for students with IEPs, and the possibilities for their child. We will examine Free and Appropriate Public Education (FAPE) within the context of students who experience many services focused on behavioral control and not many services focused on meaningful academic progress. Part 2: There is a heavy emotional toll on anyone who frequently responds to families whose children have been sent home from school, segregated from peers, suspended, expelled, shown aggression towards others, or have other significant behaviors that interfere with learning, family life, and navigating the community. This session will allow participants to share their stories as we provide resources and language that Parent Center staff can utilize when responding to parents. We will also discuss strategies to improve our compassion resiliency that can be shared with families.	
Adams	Supporting Families in a Climate of Perpetual Trauma and Fear Tery Medina and Kori Hamilton Biagas As families begin to experience more persistent and explicit social and emotional trauma, we find that our roles must evolve to support this growing climate of fear and unambiguous marginalization of communities. This session will frame the historical patterns of migration to the US, US immigration law, and will highlight some simple yet impactful tools that can support families. The presenters will share key terms related to the discourse shaping our current social climate, provide timely resources, and co-create an environment of trust and collaboration to facilitate co-teaching and learning. This session will build the capacity of participants around immigration, immigrant rights, implicit bias, and the impact of trauma.
